The type of personal information we collect:

We currently collect and process the following information:

- Personal identifiers, contacts and characteristics:
- Name
- Email address
- Telephone number
- Company Role / Title
- Website user stats
- IP address (a unique identifier for your computer or other device)
- ID Information provided by you in relation to submitting a job application to us (this may include sensitive personal information e.g. ethnic origin)

How we get the personal information and why we have it:

Most of the personal information we process is provided to us directly by you for one of the following reasons:

- To provide information you have requested via gated forms
- To allow you to attend events & webinars you have expressed interest in or submitted attendance for
- To provide you with newsletters and marketing campaigns you have subscribed to
- To process and respond to job applications
- To respond to any questions or queries you have submitted to us via email, social, phone or mail

We may share this information with third party organisations or individuals, to help us for the purposes set out above and in this policy.

Under the General Data Protection Regulation (GDPR), the lawful bases we rely on for processing this information are:

- (a) Your consent - you have the right to withdraw your consent and personal information at any time. You can do this by contacting us on 020 7749 2605.
- (b) We have a contractual obligation.
- (c) We have a legitimate business interest.

How we store your personal information:

Your information is securely stored and we do not keep your personal data for any specific period but will keep it no longer than is necessary for the purpose(s) it was provided for.

Your data protection rights:

Under data protection law, you have rights including:

Your right of access - You have the right to ask us for copies of your personal information.

Your right to rectification - You have the right to ask us to rectify personal information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.

Your right to erasure - You have the right to ask us to erase your personal information in certain circumstances.

Your right to restriction of processing - You have the right to ask us to restrict the processing of your personal information in certain circumstances.

Your right to object to processing - You have the the right to object to the processing of your personal information in certain circumstances.

Your right to data portability - You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.
